- UNHCR, Eurostat, WHO, CDAF data, EMCDDA and HRI reports
- 10 countries in the Ukrainian Refugee Response Plan + Russian Federation
- National Strategic Plans on viral hepatitis and substance use disorder treatment and care
- Oficial guidance issued to health workforce and/or refugees after full-scale invasion of Ukraine
 - Decree/orders issued by Ministry of Health, sanitary authorities or disclosed in dedicated portal for refugees from Ukraine
- Search in English and country language:
 - "(recommendation OR guidance OR guidelines OR orientation) AND ("Ukrainian refugees" OR "refugees from Ukraine" OR (Ukraine AND refugee) AND (viral hepatitis OR hepatitis) AND (Poland OR Czechia OR "Czech Republic" OR Slovakia OR "Slovak Republic" OR Moldova OR Romania OR Bulgaria OR Hungary OR Latvia OR Lithuania OR Estonia OR "Russian Federation" OR "Russia")"
